

RESOLUTION NO. 120

A RESOLUTION OF THE BOARD OF WATER COMMISSIONERS OF WHATCOM COUNTY WATER DISTRICT NO. 8, ROUTE 1, BLAINE, WASHINGTON, AMENDING THE DEVELOPERS EXTENSION POLICY FOR WATER SERVICE EXTENSION.

WHEREAS, the Board of Water Commissioners of this District has adopted Resolution No. 76 establishing a Developers Extension Policy for the water system of Whatcom County Water District No. 8, and

WHEREAS, the Water District desires to amend said Resolution to change the requirements on performance and maintenance bonds,

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Whatcom County Water District No. 8, of Whatcom County, Washington, as follows:

Paragraph No. 14 of said Resolution No. 76, is hereby amended to read as follows:

14)(a) Performance Bond. The Developer, or his contract, shall furnish to the District a Performance Bond between the Developer and the District upon the form approved by the District and in an amount equal to the engineers' estimated cost of the project, or its actual cost, if known, prior to the commencement of the work, or the Developer shall provide evidence of a performance bond requiring construction of the water extension which is satisfactory to the District. The performance bond shall require the developer or his contractor to pay all persons furnishing labor and materials and shall hold the District harmless from any claims therefor, whether any such claim would arise under the public works liens statutes or the mechanics liens statutes in the State of Washington in compliance with the formal requirements that either or both of such statutes shall not be in condition to recovery upon said bond.

(b) Maintenance Bond. The Developer shall provide a maintenance bond in the sum of fifteen per cent (15%) of the construction cost of the water system installed. Said bond shall guarantee maintenance for one year after acceptance of the extension by the District and shall be in a form acceptable to the District.

Except as herein amended said Resolution No. 76 is hereby ratified and confirmed in all respects.
