RESOLUTION NO. 159 A RESOLUTION of the Board of Commissioners of Water District No. 8 of Whatcom County, Washington, creating Utility Local Improvement District No. 5 of the Water District and establishing the boundaries thereof; ordering the acquisition, construction and installation of certain improvements therein; adopting detailed plans therefor; and declaring the estimated cost thereof. WHEREAS, a comprehensive plan or scheme of water supply for the District was adopted by the Board of Commissioners on June 19, 1969 by Resolution No. 12, which plan was ratified by the qualified electors of the water district on September 8, 1969, and has been subsequently amended, from time to time; and WHEREAS, on May 6, 1976 the Board of Commissioners of the District adopted Resolution No. 153, as amended by No. 155, (the "Resolution of Intention") wherein the Board declared its intention to create Utility Local Improvement District No. 5 and to improve the area within the proposed boundaries of said Utility Local Improvement District by the acquisition, construction and installation of certain water transmission and storage facilities together with all appurtenances necessary therfor, all as provided in the comprehensive plan of the District; and WHEREAS, notice of the hearing on the Resolution of Intention was given by publication and mailing in the manner required by law; and WHEREAS, as provided in the Resolution of Intention and notices of hearing, said hearing was held at 10:00 o'clock a.m., June 17, 1976 at the Grange Hall, Birch Bay, Washington, at which time and place the Board of Commissioners of the Water District heard all objections made by persons affected by the formation of Utility Local Improvement District No. 5 and considered all of the same and all of the written objections to the formation presented and filed at the office of the Secretary of the Board of Commissioners

bond anticipation warrants in an amount not exceeding \$100,000 which have a lien upon the Gross Earnings and Revenue of the System junior and inferior to the lien of the Warrant. Section 6. The Warrant shall be in substantially the following form: UNITED STATES OF AMERICA No. W-1 \$130,000 STATE OF WASHINGTON WATER DISTRICT NO. 8 WHATCOM COUNTY, WASHINGTON 1976 WATER REVENUE BOND ANTICIPATION WARRANT Water District No. 8, Whatcom County, Washington (the "District"), a municipal corporation of the State of Washington, acknowledges itself to owe and for value received promises to pay to bearer on the first day of January, 1977 the principal amount of ONE HUNDRED THIRTY THOUSAND DOLLARS together with interest thereon at the rate of 6% per annum, payable at maturity. Both principal and interest are payable in lawful money of the United States of America at the office of the Treasurer of Whatcom County in Bellingham, Washington solely out of the special fund of the District known as the "1976 Bond Anticipation Warrant Fund" created by Resolution No. of the District. -5-

This Warrant is issued pursuant to the Constitution and laws of the State of Washington and duly adopted resolutions of the District for the purpose of temporarily financing the acquisition, construction and installation of certain additions, improvements and betterments to and extensions of the water supply and distribution system of the District. This Warrant is payable out of the proceeds of sale of water revenue bonds of the District and out of the Gross Earnings and Revenue (as such term is defined in said Resolution No. ___) of the District legally available for such purpose after payment of the normal expense of maintenance and operation of the System and the amounts due as principal of and interest on the water revenue bonds of the District dated January 1, 1974. The District hereby covenants and agrees with the owner and holder of this Warrant that it will keep and perform all the covenants of this Warrant and of said Resolution No. to be by it kept and performed. The District has reserved the right to prepay and redeem this Warrant at par plus accrued interest to the date of redemption at any time in accordance with the provisions of said Resolution No. It is hereby certified and declared that this Warrant is issued pursuant to and in strict compliance with the Constitution and laws of the State of Washington and resolutions of the District, and that all acts, conditions and things required to have happened, been done and performed precedent to and in the issuance hereof have happened, been done and performed. IN WITNESS WHEREOF, Water District No. 8, Whatcom County, Washington has caused this Warrant to be executed in its name by the President of its Board of Commissioners, to be attested by the Secretary of its Board of Commissioners, and the corporate seal of the District to be impressed hereon this day of 1976. Section 8. The Warrant shall be signed on behalf of the Board of Commissioners by its President and shall be attested by its Secretary.

prior to the time and date of said hearings; and WHEREAS, after consideration of all of said written and oral protests the Board of Commissioners now finds that Utility Local Improvement District No. 5 should be created, encompassing the property described in the Resolution of Intention, and that the improvements described in said resolution to be acquired, constructed and installed, should be ordered to be so acquired, constructed and installed; KNOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Water District No. 8, Whatcom County, Washington as follows: Section 1. After due consideration of all of the oral and written protests made and filed to the creation of Utility Local Improvement District No. 5 and to the ordering of the acquisition, construction and installation of the improvements provided in the comprehensive plan of the water district as amended for the area in Utility Local Improvement District No. 5, as such improvements are more particularly described in the Resolution of Intention and herein, it is hereby found and ordered that Utility Local Improvement District No. 5 of Water District No. 8, Whatcom County, Washington should be and is hereby created as of the date of adoption of this resolution, and the boundaries thereof are hereby fixed as set forth in Exhibit A attached hereto and by this reference made a part hereof. Section 2. The acquisition, construction and installation of the improvements described on Exhibit B attached hereto and by this reference made a part hereof, all of which will be of special benefit to the property within the boundaries of Utility Local Improvement District No. 5, is hereby ordered. Such improvements shall be installed complete with all valves, fittings, and other auxiliary equipment necessary and commonly used or required for complete water supply and distribution systems, and shall be connected with each other. The District shall acquire by purchase, franchise, lease or condemnation all property, both real and personal, or any interest therein and all rights of way, franchises and easements which may be found necessary to acquire, construct and install the above-described -2improvements which are all as more particularly set forth in the maps and plans prepared by URS Company, consulting engineers of Seattle, Washington.

It is hereby further provided that the hereinbefore authorized plan of improvements shall be subject to such changes as to details of pipe size and location or any other details not affecting the service to be provided thereby as shall be authorized by the Board of Commissioners either prior to or during the actual course of construction.

Section 3. The estimated cost and expense of carrying out said plan of improvements is hereby declared to be as near as may be the sum of \$1,550,000, of which sum all costs not provided for by grants received by the District for such purposes shall be borne by assessments levied against property within Utility Local Improvement District No. 5 and specially benefited by said improvements. It is expected that approximately \$160,000 of such costs will be covered by governmental grants to be received by the District. The assessments shall be paid into the Revenue Bond Fund of the District heretofore created.

Section 4. In computing assessments for the cost of acquiring, constructing, and installing the hereinbefore described improvements, the nature thereof and the properties abutting upon, adjacent or vicinal to the same is such that the special benefits conferred upon all of such properties are not in all cases fairly reflected by the zone and termini method of computing assessments, and in such cases the assessments shall then be made against such properties in accordance with the special benefits which they will derive from said improvements, without regard to the zone and termini method of computation of assessments.
