

RESOLUTION NO. 163

A RESOLUTION OF THE BOARD OF WATER COMMISSIONERS



Beginning at the Northeast corner of the Northwest 1/4 of Section 22, Township 40 North, Range 1 West, W. M.;

Thence Southerly along the North-South centerline of said Section 22 and the East line of Government Lot 1, Section 27, Township 40 North, Range 1 West, W. M. to its intersection with the line of extreme low tide of Birch Bay of Georgia Strait;

Thence Northwesterly and Northerly along said line of extreme low tide to its intersection with the North line of Section 21 Township 40 North, Range 1 West, W. M.;

Thence Easterly along the North line of said Section 21 and the North line of said Section 22 to the Northeast corner of the Northwest 1/4 of Section 22 and the Point of Beginning.
