RESOLUTION NO. 217

A RESOLUTION OF THE BOARD OF WATER COMMISSIONERS OF WHATCOM COUNTY WATER DISTRICT NO. 8, WHATCOM COUNTY, WASHINGTON, FIXING THE TIME AND PLACE OF HEARING ON A PETITION FOR ANNEXATION OF CERTAIN TERRITORY TO THE WATER DISTRICT.

WHEREAS, there has been filed with the Board of Commissioners of Whatcom County Water District No. 8 of Whatcom County, Washington, hereinafter called the Board, petitions asking that certain territory be annexed to the District, a copy of said petition is attached and designated Exhibit "A" incorporated by reference herein; and

WHEREAS, the Board has examined said petition and the signatures appended thereto and has caused the signatures to be checked against the respective tracts and parcels of land as they appear in the records of the Auditor of Whatcom County, Washington; and

WHEREAS, the Board finds that the above described petition is signed by the owners of not less than sixty (60%) percent of the area of land within the territory proposed to be annexed, that such territory is contiguous to and in the same county as Whatcom County Water District No. 8; and

WHEREAS, the Commissioners of Whatcom County Water Distict No. 8 by motion on the 14th day of April, 1977, authorized the attorneys herein to proceed with the publishing of notice of the meeting to hear the above named petition;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Whatcom County Water District No. 8, as follows:

Section 1: The petition for annexation of certain territory to Whatcom County Water District No. 8, a copy of which is attached hereto and designated as Exhibit "A" is entertained by the Board at a public hearing on such proposed annexation shall be held on the Yell day of John 1977, at the hour of 10:00 A.M. at the office of Whatcom County Water District No. 8 located at Birch Bay, Washington, at which hearing all interested persons are invited to appear and voice approval or disapproval of said proposed annexation.

Section 2: The attorneys of the District are hereby instructed to cause a notice of said hearing in the form attache hereto designated Exhibit B and incorporated by reference herein, to be published once in the Bellingham Herald prior to said hearing date and is f further instructed to post three copies of said notice in three public places in the area proposed for annexation.
