

RESOLUTION NO. 222

A RESOLUTION OF THE BOARD OF WATER COMMISSIONERS OF WHATCOM COUNTY WATER DISTRICT NO. 8 AMENDING RESOLUTION NO. 75, ESTABLISHING RULES, REGULATIONS AND PROCEDURES FOR APPLYING FOR WATER SERVICE AND PAYMENTS AND FEES FOR WATER SERVICE AND GENERAL FACILITIES.

WHEREAS, the Board of Water Commissioners of Whatcom County Water District No. 8 are required to establish equitable rules and regulations within the District to provide for smooth functioning and efficient regulation of services within said District; and

WHEREAS, Whatcom County Water District No. 8 has determined that there exist inefficient and inequitable procedures within the District as exposed by recent changes within the District and the size of the District; and

WHEREAS, it is the duty of the Commissioners to make changes in the rules and regulations at such time as difficulties and inefficiencies appear;

NOW, THEREFORE, BE IT RESOLVED by the Board of Water Commissioners of Whatcom County Water District No. 8, of Whatcom County, Washington, as follows:

Section 1: Section III, subsection D of Resolution No. 75 is hereby amended to read as follows:

Turn off - \$18.00 each time  
Turn on - \$18.00 each time

Section 2: Section IV, subsection A of Resolution No. 75 is hereby amended to read as follows:

Each primary service, 500 cubic feet or less \$ 6.00  
Each 1" primary service is stricken.  
Each 1/4" primary service is stricken.  
Each 1 1/2" primary service is stricken.  
Each 2" primary service is stricken.  
Each secondary service, 500 cubic feet or less \$ 6.00  
Each extended service, 200 cubic feet of less \$ 2.50

Section 3: The "Conditions" section of subsection A of Section IV of Resolution No. 75 is hereby amended to read as follows:

- No. 1 remains unchanged.  
No. 2. Secondary Service rates apply to each habitation maintained for rental purposes to the general public by a primary customer that is rented or occupied on a seasonal basis. Secondary service rates apply for the seven (7) months period from April 1 to November 1. Each secondary service or group of secondary services shall be associated with a primary service on the same tract. Water statements for secondary service will be included with the statement of the associated primary service. Secondary services shall include resort cabins, trailer pads with water and sewer hookups, hotels and motels.  
No. 3. Extended Service rates apply to stand-pipes or water outlets installed for the use of persons other than the owner of the premises. Extended services shall include washrooms,

laundry rooms, bath houses, transient camper stand-pipes, stand-pipes in picnic and camping areas and all other similar installations. Extended service rates apply for the seven (7) month period from April 1 to November 1.

Section 4: Section V, subsection A of Resolution No. 75 is hereby amended to read as follows:

This shall be added to subsection A as an additional paragraph.

New customers shall be billed according to the time of the month in which they apply for service. During the first month of the two-month billing period, if a new customer applies prior to the 15th day of said month, he shall be billed for the entire two-month period. If a new customer shall apply for service after the 15th day of the first month, he shall be billed only for the second month of the two-month period.

Section 5: The remainder of Resolution No. 75, with the exception of those sections amended by other resolutions, shall remain unchanged.

Each primary service, 500 cubic feet or less \$ 6.00  
Each 1" primary service is stricken.  
Each 1/4" primary service is stricken.  
Each 1 1/2" primary service is stricken.  
Each 2" primary service is stricken.  
Each secondary service, 500 cubic feet or less \$ 6.00  
Each extended service, 200 cubic feet or less \$ 2.50

Section 3: The "Conditions" section of subsection A of Section IV of Resolution No. 75 is hereby amended to read as follows:

- No. 1 remains unchanged.
- No. 2. Secondary Service rates apply to each habitation maintained for rental purposes to the general public by a primary customer that is rented or occupied on a seasonal basis. Secondary service rates apply for the seven (7) months period from April 1 to November 1. Each secondary service or group of secondary services shall be associated with a primary service on the same tract.
