

RESOLUTION NO. 27

A RESOLUTION of the Board of Commissioners of Whatcom County Water District No. 8, Whatcom County, Washington, adopting a comprehensive plan for a sanitary sewage collection, treatment and disposal system for the district; providing a method of paying the cost of such plan; and finding and declaring an emergency requiring the calling of a special election for the submission to the qualified electors of the district of the proposition of whether or not the district should issue its sewer revenue bonds in the principal amount of not to exceed \$5,211,900 for the purpose of providing funds to pay part of such cost.

WHEREAS, Whatcom County Water District No. 8, Whatcom County, Washington, (herein called the "District") presently does not have a sanitary sewage system; and

WHEREAS, the health of the residents of the District is being endangered by the lack of a sewage system, which danger may be abated by the acquisition and construction of the sanitary sewage system described and specified herein; and

WHEREAS, the Board of Commissioners of the District has investigated all portions and sections of the District and selected a plan for a system of sewers for the District suitable and adequate for the present and reasonably foreseeable future needs thereof; and

WHEREAS, it is deemed necessary and advisable that part of the money necessary to acquire and construct the hereinafter described sanitary sewage system be provided by the issuance and sale of sewer revenue bonds of the District in the principal sum of not to exceed \$5,211,900, and by the creation of a utility local improvement district or districts within the District and the levying of assessments within such utility local improvement district or districts.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Whatcom County Water District No. 8 as follows:

Section 1. The following Comprehensive Plan for a system of sanitary sewage collection and treatment and disposal for Whatcom County Water District No. 8 is hereby adopted, to-wit:

A. The District shall construct and install sewer trunk lines, laterals, pressure mains and outfalls in, on and along property, streets, roads, or easements, all as described in Exhibit A attached hereto and incorporated by reference herein.

B. The District shall construct and install eleven lift/pump stations of varying sizes employing a minimum of two pumps each, with all appurtenances necessary thereto, and wherever found to be necessary to provide a proper flow of sewage within the said system. The lift/pump stations shall be located as follows:

- No. 1 On Birch Bay Dr. 900 ft. northeasterly of Pt. Whitehorn Rd.
- No. 2 Intersection of extension of Bay Rd. and Birch Bay Dr.
- No. 3 Intersection of Birch Bay Dr. and Maple St.
- No. 4 Intersection of Birch Bay Dr. and Alderson Rd.
- No. 5 Birch Bay Dr. approximately 400 ft. north of Evergreen Lane.
- No. 6 Intersection of Birch Bay Dr. and Drayton Harbor Road.
- No. 7 Intersection of Birch Bay Dr. and Beach Way Dr.
- No. 8 Birch Bay Dr. approximately 300 ft. westerly of Deer Trail.
- No. 9 Sehome Rd. approximately 900 ft. north of south line of
Section 23.

- No. 18 Intersection of Terrell Road and N-S centerline, Sec. 1.
- No. 19 Intersection of Terrell Road and Jackson Road.

C. The District shall construct a sewage treatment plant with all necessary units for comminution, sedimentation, digestion, grit removal, aeration and disinfection, with all necessary mechanical, electrical and other devices and appurtenances required to reduce the sewage and produce an effluent meeting the requirements

of all federal, State of Washington and Whatcom County regulatory agencies and offices, on property to be acquired by the District by purchase or condemnation in the southern portion thereof.

D. The District may install wyes and connecting 6-inch side sewers from any main line or lateral to the adjacent or vicinal property lines or to the outside boundary of any permanent easement.

The District shall acquire, construct, reconstruct and repair all manholes, lampholes, tees, side sewers, wyes, valves, drains, pumping and all other equipment and appurtenances necessary for the adequate operation of the above described comprehensive plan.

E. The District shall acquire, by purchase or condemnation, gift or grant, all property, both real and personal, or any interest therein, and all easements, rights-of-way and franchises, which may be found necessary to carry out the above described comprehensive plan. Said comprehensive plan is all as more particularly set forth in maps and plans, prepared by Hill, Ingman & Chase Co., Consulting Engineers and Analysts, of Seattle, Washington and now on file with the District.

F. It is hereby further provided that the above described plans shall be subject to such changes in the type, location and size of pipe, or in any other details of said plan not affecting the service provided thereby as shall be authorized by the Board of Commissioners, either prior to or during the actual course of construction.

In the event that final design, surveys, comparative cost studies or bids indicate the advantage of alternate locations or grades or the use of pumping facilities rather than gravity facilities, then such changes may be authorized by the Board of Commissioners.

Section 2. The estimated cost of the foregoing plan as authorized in Section 1 of this resolution is hereby declared to be, as near as may be, the sum of \$7,041.900.

To provide the funds to pay part of the cost of the comprehensive sewage plan above provided the issuance and sale of revenue bonds of the District in the total sum of \$5,211,900 is hereby authorized. The balance of such cost shall be paid out of federal or State of Washington grants available for sewage work projects, from the general funds of the District and from any other legally available source.

Section 3. All of the land within the District which will be specially benefited by the acquisition and construction of the above described plan may be included in one or more utility local improvement districts and assessments may be levied in said district or districts in amounts within the special benefits received by the properties therein by virtue of the acquisition and construction of such comprehensive plan.

Section 4. All of the \$5,211,900 of sewer revenue bonds authorized herein, shall bear interest at a rate not to exceed the maximum rate permitted by law at the time of their sale, shall be issued in amounts and at such time or times with such terms, conditions and covenants as may be found necessary, may be combined in one issue or issued in more than one series, and may mature in various amounts in not to exceed 30 years from date of issue.

Both principal of and interest on all said bonds shall be paid from the gross revenue of the sewerage system of Whatcom County Water District No. 8 and from assessments as authorized in this resolution and any further resolution authorizing additions and betterments to the comprehensive plan of the District for a system of sewers.

Section 5. It is hereby found and declared that an emergency exists requiring the submission to the qualified electors of the District of the proposition of whether or not the District should be authorized to issue and sell such sewer revenue bonds for such purposes at a special election to be held therein on July 20, 1971. The Whatcom County Auditor as ex-officio supervisor of elections within Whatcom County is hereby requested to also find the existence of such emergency and to call and conduct said special election, fix the polling place or places thereof, and the name of the election officials to serve at each polling place.

The proposition to be submitted to such qualified electors at such special election shall be as follows:

PROPOSITION NO. 1

WHATCOM COUNTY WATER DISTRICT NO. 8
REVENUE BONDS, \$5,211,900

Shall Whatcom County Water District No. 8, Whatcom County, Washington, for the purpose of providing part or all of the funds necessary to carry out the comprehensive plan of the District for a sewage system, issue its sewer revenue bonds in the principal amount of \$5,211,900, or such part thereof as may be found to be necessary to carry out said plan, such bonds to bear interest at a rate not to exceed the maximum rate permitted by law at the time of their sale, to mature in not to exceed 30 years from date of issue, and to be payable from the gross revenue of the sewage system of the district and from assessments duly and regularly levied, all as more fully provided in Resolution No. _____ of the Board of Commissioners of the District adopted June 3, 1971?
