WATER DISTRICT NO. 8 OF WHATCOM COUNTY, WASHINGTON RESOLUTION OF INTENTION TO CREATE UTILITY LOCAL IMPROVEMENT DISTRICT NO. 1 RESOLUTION NO. 30 A RESOLUTION of the Board of Commissioners of Water District No. 8 of Whatcom County, Washington, declaring the intention of the Board to order the formation of a utility local improvement district for the construction and installation of that part of the Comprehensive Plan of the water district applicable to and covering the area within the boundaries of said proposed utility local improvement district, setting forth the nature and territorial extent of such proposed improvement, designating the number of the utility local improvement district, describing the boundaries thereof, stating the estimated cost and expense of the improvement and the amount thereof proposed to be borne by the property within the proposed utility district, and fixing a date, time and place for a public hearing on the formation of such district. WHEREAS, on June 19, 1969, the Board of Commissioners hatcom Washington, adopted of Water District No. 8 of a Comprehensive Plan of water supply and distribution for the district; and WHEREAS, the Board of Commissioners has, from time to time, amended said Comprehensive Plan of water supply and distribution for the district; and WHEREAS, the Board of Commissioners has received a petition signed by the owners of more than 51% of the area of land herein described petitioning that a utility local improvement district be formed within said area for the purpose of constructing a water system therein; and WHEREAS, it is deemed necessary and advisable, economically feasible and to the best interests of the district and its inhabitants that the acquisition, construction and installation of the portion of the improvements described in said Comprehensive Plan, as amended,

applicable to the area hereinafter described, be ordered and that a utility local improvement district be created and assessments levied therein in order to pay part of the principal of and interest on the water revenue bonds to be issued by the district to pay the cost of the acquisition, construction and installation of such improvements;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Water District No. 8 of Whatcom County, Washington, as follows:

Section 1. It is the intention of the Board of Commissioners of the district to order the improvement of the area within the district described in Exhibit A attached hereto, by the acquisition, construction and installation of the improvements described in Section 2 of this resolution as petitioned for by the owners of more than 51% of the land within said area. Said petition is hereby found and determined to be sufficient in all respects.

Section 2. The nature and territorial extent of the proposed improvements for said area shall be that portion of the general Comprehensive Plan of water supply for the district more particularly described as follows:

The district shall acquire, construct and install the following described supply and distribution lines in, along and under the following described streets and drives:

The above-described water supply and distribution lines shall be installed complete with all valves, fittings, hydrants and other auxiliary equipment necessarily and commonly used or required for complete water supply and distribution.

The district shall acquire by purchase, franchise, lease or condemnation all property, both real and personal, or any interest therein and all rights of way, franchises and easements which may be found necessary to acquire, construct and install the above-described improvements which are all as more particularly set forth in the maps and plans prepared by Hill, Ingman, Chase & Co., Consulting Engineers of Seattle, Washington.

It is hereby further provided that the hereinbefore authorized plans of improvement shall be subject to such changes as to details of pipe size and location or any other details of said plans not affecting the service to be provided by the main general plan and as shall be authorized by the Board of Commissioners either prior to or during the actual course of construction.

Section 3. Said proposed utility local improvement district shall be designated "Utility Local Improvement District No. 1." The estimated cost of acquiring, constructing and installing said plan of improvements described in Section 2 hereof is hereby declared to be as near as may be the sum of \$60,000, and it is proposed that all of such cost will be borne by assessments levied against property within the proposed utility local improvement district and specially benefited by said improvements.

Section 4. All persons who may desire to object to

the formation of the proposed utility local improvement district and
the ordering of said improvements are hereby notified to present
such objections in writing to the Secretary of the Board of Commissioners
of the district prior to the meeting of the Board of Commissioners

of the district to be held at 8:00 o'clock P.M. on November 4,
1971, at the offices of LeCoq, Simonarson and Durnan, 828 Peace
Portal Drive, Blaine, Washington, which time and place are hereby
fixed for hearing all matters relating to the creation of said
utility local improvement district, the ordering of the proposed
improvements, the method of payment therefor and all objections
thereof.

Section 5. The Secretary of the Board of Commissioners
of the District is hereby directed to give notice of said hearing
by publication of a notice of adoption of this resolution and by
mailing such notice thereof in the manner required by law.
