

RESOLUTION NO. 361

A RESOLUTION OF THE BOARD OF WATER COMMISSIONERS OF WHATCOM COUNTY WATER DISTRICT NO. 8, WHATCOM COUNTY, WASHINGTON, CONCERNING WATER RATES, AND AMENDING SECTION 1 OF RESOLUTION 320.

BE IT RESOLVED by the Board of Commissioners of Whatcom County Water District No. 8, Whatcom County, Washington, as follows:

Section 1: Section 1 of Resolution 320 is hereby amended to read as follows:

Monthly Water Rates:

Class 1	- Residential Inside District	\$3.50 per living unit
Class 2	- Residential Outside District	\$5.25 per living unit
Class 3	- Commercial Inside District	\$3.50 per business
Class 4	- Commercial Outside District	\$5.25 per business
Class 5	- Industrial	(Not yet set)
Class 6	- Extended Service	\$1.00 each

In addition to the above monthly charges, customers shall be charged sixty cents (\$.60) for each 100 cubic feet of water used by them.

The phrase "living unit" shall mean any improved real property or portion thereof which is used or occupied, or is intended, arranged, or designed to be used at the home, residence, or sleeping place, of one or more human beings, but not more than one family. Without intending to limit the above definition in any way, the phrase "living unit" is intended to include each and every trailer pad with water facilities, apartment unit in an apartment complex, and each cottage or portion thereof used or intended to be used by one family whether actually occupied or not.

Water service charges shall be terminated at such time as the structure is either removed, destroyed, condemned, or not longer requires water service in the opinion of the District, provided the request for discontinuation of service is received in writing and all other services provided by the District have been terminated according to the rules and regulations thereof.

In the event water service is again requested and the basic use of the property has not changed in the opinion of the District, service will not be provided until a charge equal to the base charge per living unit, per business and/or per extended, times the number of months since the service was terminated is paid, along with any other required fees. This charge will apply only if the termination has been twelve (12) months or less.


