

RESOLUTION NO. 383

RESOLUTION OF THE BOARD OF COMMISSIONERS OF WHATCOM COUNTY WATER DISTRICT NO. 8, WHATCOM COUNTY, WASHINGTON, RAISING THE CHARGES FOR USE OF ITS SEWER SYSTEM, FIXING RATES AND CHARGES FOR SEWAGE DISPOSAL SERVICE AND AMENDING RESOLUTION NO. 139 AND 301

BE IT RESOLVED by the Board of Commissioners of Whatcom County Water District No. 8, Whatcom County, Washington, as follows:

Section 1: Section 1 of Resolution No. 139 and Section 1 of Resolution No. 301 shall be amended to read as follows:

1. The following rates and charges for furnishing sewage disposal services to property within the district, where available, whether or not a connection to the sewerage system of the District has been made, within the following classifications of users, are hereby fixed and shall be paid therefor, to-wit:

- a. Residential within the district: \$8.00 per living unit per month;
- b. Residential outside the district: \$12.00 per living unit per month;
- c. Commercial (Public Retail, Non-Residential): \$8.00 per month minimum charge for the first 1,000 cubic feet per month of water usage, plus \$0.65 per month per 100 cubic feet or part thereof in excess of 1,000 cubic feet.
- d. Industrial (any non-governmental user of publicly owned treatment works identified in the Standard Industrial Classification Manual 1972, Office Management and Budget, as amended and supplemented under the following divisions; Division A: Agriculture, Forestry and Fishing; Division B: Mining; Division D: Manufacturing; Division E: Transportation, communications, electric, gas and sanitary services; Division I: Services; A user in the Divisions listed may be excluded if it is determined that it will introduce primarily segregated domestic wastes or wastes from sanitary conveniences) Rates to be established individually by contract to be commensurate with other charges in the District, however, rates will comply with the Federal Guidelines and/or regulations pursuant to the Water Pollution Control Act Amendments of 1972.

Section 2: BE IT FURTHER RESOLVED that any resolutions of parts of resolutions in conflict herewith are hereby repealed insofar as they conflict with the sewer service charges herein adopted.

Section 3: The effective date of this ^{Resolution} ordinance shall be January 1, 1982.
