RESOLUTION NO. 399 A RESOLUTION OF THE BOARD OF COMMISSIONERS OF BIRCH BAY WATER DISTRICT NO. 8, WHATCOM COUNTY, WASHINGTON, RELATING TO AND PROVIDING FOR TIME LIMITS AND FEES FOR SIDE SEWER CONNECTIONS EFFECTIVE FEBRUARY 1, 1984, AND AMENDING RESOLUTIONS NOS. 143, 149 and 371. BE IT RESOLVED by the Board of Commissioners of Birch Bay Water District No. 8, Whatcom County, Washington, as follows: Section 1: Section I A,B & C of Resolution No. 143 and Section 1 of Resolution No. 371 are hereby amended to read as follows: Effective February 1, 1984, the fees and charges of the District as they pertain to side sewers shall be: Single family dwelling -Permit fee - \$50.00 if the permit is issued to a registered side sewer contractor and \$100.00 if the permit is issued to any other person. Renewal fee - no charge Modification fee - \$10.00 Repair - permit required, no charge Capping - permit required, no charge B. Multiple Dwelling -Permit fee - \$50.00 for first dwelling unit if the permit is issued to a registered side sewer contractor and \$100.00 if the permit is issued to any other person; and \$15.00 for each additional dwelling unit. Renewal fee - no charge Modification fee - \$10.00 per unit Repair fee - \$10.00 Capping fee - \$10.00 per cap required C. All other structures -Permit fee - \$50.00 minimum fee if the permit is issued to a registered side sewer contractor and \$100.00 if the permit is issed to any other person; plus \$.01 per square foot of ground area occupied by such structure and its foundation over 4000 square feet through 10,000 square feet; plus \$.005 per square foot for the remainder in excess thereof. Renewal fee - no charge Modification fee - \$10.00 Repair fee - \$10.00 Capping fee - \$10.00 per cap required Section 2: Section 4.01 of Resolution No. 149 is hereby amended to read as follows: Application and issuance. Prior to connection of any house, building, or structure to the public sewer or the making of any repairs, alterations, or additions to any side sewer or line connected thereto, an application for a side sewer permit on an appropriate form provided by the District, shall be filed by the owner or his agent at the District office. The permit application shall be supplemented by any plans, specifications or other information considered pertinent in the judgment of the District. Upon approval of the application the District shall

issue a side sewer permit to the applicant, which permit shall be authorization to the applicant to proceed to connect in accordance with the permit. If the applicant proceeds in any manner other than as authorized, the District may require the applicant to redo any work that is not in accordance with the permit.

Any permit shall be valid for thirty (30) days unless extended or renewed by the District upon good cause shown, upon application therefore, prior to the original expiration date. A renewal permit shall be valid for not more than thirty (30) days.

Section 3: This resolution shall become effective on February 1, 1984, and shall apply to any side sewer connection applications made but not completed prior to that date.

Section 4: All resolution or parts of resolution that conflict herewith are hereby repealed.
