

RESOLUTION NO. 426

A RESOLUTION OF THE BOARD OF COMMISSIONERS  
OF BIRCH BAY WATER DISTRICT NO. 8 AUTHORIZING  
TEMPORARY SEWER AND WATER HOOKUPS DURING EXPO 86.

WHEREAS, a world exposition called "Expo '86" will be held in Vancouver, British Columbia, Canada between May 1, and October 31, 1986; and

WHEREAS, current District Resolutions call for substantial payments for general facilities charges for hookup to the District's water and sewer systems; and

WHEREAS, the District now has the capacity to serve additional customers during 1986; and

WHEREAS, the District Commissioners consider it to be in the District's best interest to allow temporary hookups during Expo '86;

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of Birch Bay Water District No. 8 as follows:

1. Existing Underutilized Parks. The current policy of the District is to begin charging monthly sewer and water charges to each unit in an existing mobile home or recreational vehicle park when each unit is first utilized and to confirm charging for it thereafter regardless of whether it continues to be used. Between May 1, 1986 and October 31, 1986, previously unused units may be opened at the park owners request; may be served for said full period of time at the District's normal water and sewer charges and, at the owner's request, the charges will be discontinued on October 31, 1986 until service is again requested to that unit.

2. New Temporary Parks. New recreational vehicle parks may be opened for the period May 1, 1986 through October 31, 1986 on the following conditions:

(a) They must comply with all requirements imposed by Whatcom County for health and building permits.

(b) They will be opened May 1, 1986 and closed October 31, 1986.

(c) They will pay the appropriate side sewer permit fees required by resolution 399.

(d) They will pay the appropriate water service connection fees required by Resolution 419.

(e) They will not be subject to Resolution 405 and 406 on General Facilities charges.

(f) They will pay the normal water and sewer usage and availability charges of the District. These charges must be paid by the 15th of the months in which they are billed or District shutoff policies will be enforced for non-payment.

(g) They will pay to the District a deposit of six (6) times the monthly water and sewer availability charge applicable to the park, which sum will be held by the District to guarantee;

(1) full payment of all charges owed to the District. Any unpaid charges will be deducted from the deposit.

(2) disconnection of the systems to the satisfaction of the District by December 1, 1986. If this is not done, District employees will do it. The standard District rates for such work shall be deducted from the deposit.

(3) any balance of the deposit will be refunded.

3. Service Rates - Temporary Parks. Monthly base charges for water and sewer for temporary parks authorized in section 2 of this resolution shall be as follows:

(a) For spaces with both water and sewer available directly to the space, one-half ( $\frac{1}{2}$ ) of the residential rate;

(b) For spaces with water only but not sewer available directly to the space, one-third ( $\frac{1}{3}$ ) of the residential rate;

(c) For spaces with neither water or sewer available directly to the space, one-quarter ( $\frac{1}{4}$ ) of the residential rate.

For billing purposes, the available spaces will be totaled, multiplied by the appropriate fraction above, and rounded up to the next highest whole number.
