RESOLUTION NO. 433

A RESOLUTION OF THE BOARD OF WATER COMMISSIONERS OF BIRCH BAY WATER DISTRICT NO. 8, WHATCOM COUNTY, WASHINGTON, AMENDING RESOLUTIONS NO. 75, 222, 320, 382, 389, and 412 ESTABLISHING RULES, REGULATIONS AND PROCEDURES FOR APPLYING FOR WATER SERVICE AND GENERAL FACILITIES.

WHEREAS, the Board of Water Commissioners of Birch Bay Water District No. 8 are required to establish water changes within the District to provide for the provision of water services within said District; and

WHEREAS, Birch Bay Water District No. 8 has determined that the current water rates are insufficient to operate the water utility;

NOW, THEREFORE, BE IT RESOLVED by the Board of Water Commissioners of Birch Bay Water District No. 8 of Whatcom County, Washington, as follows:

Section 1: Section IV, subsection A of Resolution No. 75 and Section 2 of Resolution No. 222 and Section 1 of Resolutions No. 320, 382, 389 and 412 are hereby amended to read as follows:

In addition to the above monthly charges, customers shall be charged eighty cents (\$.80) for each 100 cubic feet of water used by them.

Section 2: Commercial (Public Retail, Non-Residential, including <u>Water Parks</u>: Rates shall be per equivalent living units based on meter size as follows:

Section 3: Recreational Vehicle Parks, Cabin and Motel Units:

(1) A Recreational Vehicle Park shall consist of any spaces which may be used only by Recreational Vehicles. A Recreational Vehicle is any living unit measuring forty (40) feet in length, or less, overall.

- (2) Recreational Vehicle Parks which rent or lease space for time periods greater than six (6) months or consist of spaces which are individually owned or specifically assigned to one person or group of persons shall pay on the basis of 3/4 (three-fourths) of an equivalent living unit for each such space.
- (3) Recreational Vehicle Parks renting or leasing space for periods of less than six (6) months and seasonal cabin and motel units shall pay on the following basis for each living space or recreational vehicle space:

Sewer and water available to each site or unit: 1/2 (one-half) equivalent living unit charge.

Water only available to each site or unit: 1/3 (one-third) equivalent living unit charge.

Primitive site with no water or sewer to the site or unit: 1/4 (one-fourth) equivalent living unit charge.

<u>Section 4:</u> <u>Billing charge:</u> In addition to the above charges, each billing unit shall be charged a billing and handling charge of One Dollar and fifty cents (\$1.50) per month.

Section 5: Switchover billing: Customers with account numbers 060000000 and above will be billed in January 1987 for basic unit charges for December only. They will then be billed for January, February and March basic unit charges at the beginning of March, 1987.

Section 6: The remainder of Resolutions No. 75 and 222, 320, 382, 389, and 412 with the exception of those sections amended by other resolutions, shall remain unchanged.

Section 7: This resolution shall be effective January 1, 1987.
