<u>Section 1: That the petition for annexation of certain territory</u> to Birch Bay Water and Sewer District, as described on the attached Exhibit A, is entertained by the Board and a public hearing on such proposed annexation shall be held on the office of Birch Bay Water and Sewer District, 7096 Point Whitehorn Road, Birch Bay, Washington at which hearing all interested persons are invited to appear and voice approval or disapproval of said proposed appearation proposed annexation.

<u>Section 2:</u> BE IT FURTHER RESOLVED that legal notice of the pendency of said petition and said hearing be given as provided by law and by statute of the State of Washington.

## EXHIBIT A

Beginning at the intersection of the centerline of Blaine Road with the Southerly line of the Northeast 1/4 of the Southeast 1/4 of Section 19, Township 40 North, Range 1 East of the Willamette Meridian, Whatcom County, Washington, the said point being the POINT OF BEGINNING;

Thence Westerly along said Southerly line to the West line of the East 1/2 of the Northwest 1/4 of the Southeast 1/4 of said Section 19;

Thence Northerly along said West line to the Northerly line of said Southeast 1/4 of said Section 19 (centerline of Anderson Road);

Thence Westerly along said Northerly line (centerline of Anderson Road) to the East line of the Northwest 1/4 of said Section 19;

Thence North along said East line to the common Section line of Sections 18 and 19 of said Township and Range (centerline of Lincoln Road, unimproved);

Thence Easterly on said common Section line (Lincoln Road, unimproved) to the common corner of Section 17, 18, 19 and 20, Township 40 North, Range 1 East of the Willamette Meridian (intersection of Lincoln Road, unimproved, and Blaine Road);

Thence Southerly along the Easterly line of said Section 19 (centerline of the Blaine Road) to the POINT OF BEGINNING.
