A RESOLUTION OF THE BOARD OF COMMISSIONERS OF BIRCH BAY WATER AND SEWER DISTRICT, WHATCOM COUNTY, WASHINGTON, AMENDING SECTIONS G AND H OF RESOLUTION NO. 516

BE IT RESOLVED by the Board of Commissioners of Birch Bay Water and Sewer District, Whatcom County, Washington as follows:

Section 1: Section G 8.08.060 is amended to read as follows:

8.08.060 Commencement of Payment of Rates and Charges. Upon submission to the District of an application for sewer service, and payment of a General Facilities Charge, monthly sewer service charges shall begin immediately. Any persons who have previously submitted an application for sewer service, but who have not yet connected to the sewer system, shall be given notice that they have ninety (90) days to begin paying the monthly service charges; or, if they elect not to begin paying monthly service charges, they will be required to pay any increase in General Facilities charges enacted after the date of their application for sewer service.

Section 2: Section H 7.04.082 is amended to read as follows:

7.04.082 Commencement of Payment of Rates and Charges. Upon submission to the District of an application for water service, and payment of a General Facilities Charge, monthly water service charges shall begin immediately. Any persons who have previously submitted an application for water service, but who have not yet connected to the water system, shall be given notice that they have ninety (90) days to begin paying the monthly service charges; or, if they elect not to begin paying monthly service charges, they will be required to pay any increase in General Facilities charges enacted after the date of their application for water service.

<u>Section 3</u>: BE IT FURTHER RESOLVED that any resolutions or parts of resolutions in conflict herewith are hereby repealed insofar as they conflict with the provisions of this resolution.

Section 4: If any section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Resolution. The Council hereby declares that it would have passed this code and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases has been declared invalid or unconstitutional, and if, for any reason, this Resolution should be declared invalid or unconstitutional, then the original Resolution or Resolutions shall be in full force and effect.
