RESOLUTION NO. 72 declaring the estimated cost thereof.

A RESOLUTION of the Board of Commissioners of Water District No. 8, Whatcom County, Washington, creating Utility Local Improvement District No. 2 of the water district and establishing the boundaries thereof; ordering the acquisition, construction and installation of certain improvements therein; adopting detailed plans therefor; and

WHEREAS, on April 5, 1973, the Board of Commissioners of Water District No. 8, Whatcom County, Washington, adopted Resolution No. 61, wherein the Board declared its intention to create Utility Local Improvement District No. 2 of the water district and to improve the area within the proposed boundaries of said utility local improvement district by the acquisition, construction and installation of certain sanitary sewage collection facilities together with all appurtenances necessary therefor, all as provided in the comprehensive plan for a system of sewers for the water district as added to and amended and as applicable to the area within such proposed boundaries; and

WHEREAS, notice of the hearing on said Resolution No. 61 was given by publication and mailing in the manner required by law; and

WHEREAS, as provided in said resolution and mailed notice of hearing, said hearing was held at 7:30 P.M. Daylight Saving Time on May 9, 1973 at the Grange Hall at Birch Bay, Washington, at which time and place the Board of Commissioners of the water district heard all objections made by persons affected by the formation of said utility local improvement district and considered all of the same and all of the written objections to the formation of said utility local improvement district presented and filed at the office of the Secretary of the Board of Commissioners prior to the time and date of said hearing; and

WHEREAS, after consideration of all of said written and oral protests the Board of Commissioners now finds that all of the same should be denied and that said utility local improvement district

should be created, encompassing the property described in said Resolution No. 61, and that the improvements described in said resolution to be acquired, constructed and installed should be ordered to be so acquired, constructed and installed; NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Water District No. 8, Whatcom County, Washington, as follows: Section 1. After due consideration of all of the oral and written protests made and filed to the creation of Utility Local Improvement District No. 2 and to the ordering of the acquisition, construction and installation of the improvements provided in the comprehensive plan of the water district as amended for the area in said utility local improvement district, as such improvements are more particularly described in said Resolution 61 and herein, it is hereby found and ordered (a) that all of such objections and protests be and they are hereby denied; and (b) that Utility Local Improvement District No. 2 of Water District No. 8, Whatcom County, Washington, should be and is hereby created as of the date of adoption of this resolution, and the boundaries thereof are hereby fixed as set

Section 2. The acquisition, constriction and installation of the following described improvements, all of which will be of special benefit to the property within the boundaries of said Utility Local Improvement District No. 2 is hereby ordered.

forth in Exhibit "A" attached hereto and by this reference made a part

The district shall acquire, construct and install the following described sewers in, on, along and under the following described properties, streets, avenues, places, roads, highways and easements as set forth in Exhibit "B" attached hereto and by this reference made a part hereof.

The district shall construct and install all manholes, lampholes, wyes, tees and other appurtenances necessary to the

proper operation of the sewer system of the district, all in accordance with the requirements of the regulatory agencies and offices of the State of Washington and Whatcom County. The sewer district shall acquire, by purchase or condemnation, gift or grant, or lease, all property, both real and personal or any interest therein, and all rights-of-way, franchises and easements which may be found necessary to acquire, construct and install the above described improvements, which are all as more particularly set forth in maps and plans prepared by Hill, Ingman, Chase & Company, consulting engineers of Seattle, Washington. The district shall construct and install lift pump stations of varying sizes and employing a minimum of two (2) pumps each, with all appurtenances necessary thereto and whenever found to be necessary to provide a proper flow of sewage within the said system. The district shall construct a sewage treatment plant with all necessary units for comminution, sedimentation, digestion, grit removal, aeration and disinfection, with all necessary mechanical, electrical and other devices and appurtenances required to reduce the sewage and reduce an affluent meeting the requirements of all federal, State of Washington and Whatcom County regulatory agencies and offices, on property to be acquired by the district by purchase or condemnation. It is hereby further provided that the hereinbefore authorized plan of improvements shall be subject to such changes as to details of pipe size and location, or any other details of said plan which do not affect the service to be provided by the main general plan, as shall be authorized by the Board of Commissioners of the water district either prior to or during the course of actual construction. Section 3. The detailed plans for the acquisition, construction and installation of such improvements as prepared by -3Hill, Ingman, Chase & Company, engineers for the water district, are hereby approved and adopted.

The estimated cost and expense of carrying out said plan of improvements is hereby declared to be the sum of \$8,400,000, of which approximately \$4,500,000 of such costs shall be borne by and assessed against the real property within the boundaries of Utility Local Improvement District No. 2 specially benefited by said improvements. The balance of said cost shall be paid from other moneys of the sewer district available for such purposes.

Section 4. In computing assessments for the cost of acquiring, constructing and installing the hereinbefore described improvements, the nature thereof and the properties abutting upon, adjacent or vicinal to the same is such that the special benefits conferred upon all of such properties are not in all cases fairly reflected by the zone and termini method of computing assessments, and in such cases the assessments shall then be made against such properties in accordance with the special benefits which they will derive from said improvements, without regard to the zone and termini method of computation of assessments.
