

RESOLUTION NO. 91

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF  
WHATCOM COUNTY WATER DISTRICT NO. 8, WHATCOM  
COUNTY, WASHINGTON, ANNEXING CERTAIN PROPERTY  
TO THE DISTRICT

WHEREAS, on the 5<sup>th</sup> day of September, 1974m the Board of Commissioners (hereinafter called the "Board") of Whatcom County Water District No. 8, Whatcom County, Washington, adopted Resolution No. 86 entertaining a certain petition for annexation to the District of the property hereinafter described, fixing the time and place of hearing upon said petition, and providing for the publication and posting of notice of the hearing; and

WHEREAS, such notice was published and posted as required by law and by said Resolution No. 86; and

WHEREAS, at the time and place stated in said Resolution No. 86 a public hearing was held upon said petition; and

WHEREAS, the Commissioners have determined that all of the area described in the aforesaid petition should be annexed to the District.

NOW, THEREFORE, BE IT RESOLVED by the Board of Water Commissioners of Whatcom County Water District No. 8, Whatcom County, Washington, as follows:

SECTION 1: The Borad hereby finds that the property hereinafter described should be, and it is hereby annexed to the District:

Beginning at the Northwest corner of the Northwest quarter of Section 24, Township 40 North, Range 1 West of W.M.; thence Easterly along the North line of said Northwest quarter to its intersection with the East line of the Northwest quarter of the Northwest quarter of said Section 24, (centerline Shintaffer Road); thence Southerly along said East line to its intersection with the South line of the North 12 acres of the East half of the Southwest quarter of the Northwest quarter of said Section 24; thence Westerly along said South line to its intersection with the East line of the West half of the Southwest quarter of the Northwest quarter of said Section 24; thence Northerly along said East line to its intersection with the North line of the West half of the Southwest quarter of the Northwest quarter of said Section 24; thence Westerly along said NOrth line to its intersection with the West line of the Northwest quarter of said Section 24; thence Northerly along said West line to the Northwest corner of said Section 24 and the point of beginning,

SECTION 2: Said area shall be annexed and become a part of Whatcom County District No. 8, effective on the 1<sup>st</sup> day of December, 1974.

SECTION 3: Certified copies of this Resolution shall be filed with the Board of County Commissioners, WhatcomCounty, Washington.
