RESOLUTION NO. 25 A Resolution of Whatcom County Water District No. 8, of Whatcom County, Washington, providing for the metering of all of the water system, owned by Whatcom County Water District No. 8 and the billing to all such water customers of the sum of \$50.00 for the costs of the meter and installation thereof. WHEREAS, the water system in general of Water DistrictNo. 8 of Whatcom County, Washington, has never been metered and that it is now the determination of the Board of Commissioners that it is absolutely necessary that the entire water system of Water District No. 8 be metered in order that some control may be had over leakage of water, wastage of water and other causes whereby water is wasted by the customers of the district, and WHEREAS, there is hereby declared to be the policy of the Water District No. 8 that all of said water system be metered so that a control of the use of water may be exercised, and WHEREAS, there are now insufficient funds in the general fund with which to pay for the cost of purchasing the meters and the installation thereof in the system, as it presently exists, and WHEREAS, it is not foreseen that there will be sufficient funds in the near future with which to pay for said meters and it cannot be anticipated that the funds will be available within a reasonable period of time, SECTION ONE: NOW THEREFORE, be it resolved that as a matter of policy and regulations that the entire water system of Water District No. 8 of Whatcom County, Washington, be placed on meters so that the use of water may be regulated and so that the same will not be wasted by leaks on the

system or by unreasonable useage of water by the customers.

## SECTION TWO:

THAT, to pay for the metering of said water system, all customers of the water system shall be charged a fee of \$50.00 and shall be billed the sum of \$50.00 for the costs of the meter and installation thereof, which has been determined to be the reasonable costs thereof.

THAT this \$50.00 billing may be paid in one installment or in three billing periods as set forth in a letter which shall be sent to the water users.

## SECTION THREE:

THOSE water users who are connected to the water system purchased from the Birch Bay Investors, shall not be charged this meter charge because of the fact that their system was taken over by the District with the understanding that said system has been metered completely. This shall not apply to those water users who have paid the \$250.00 service connection fee because the cost of the meter and installation there of, was charged in that service connection fee.

SECTION FOUR: ALL Resolutions or parts of resolutions in conflict herewith are hereby repealed. ADOPTED by the Board of Commissioners of Whatcom County Water District No. 8, Whatcom County, Washington, at a regular meeting thereof this 21st day of January ,1971. WHEREAS, there is insufficient funds in the Bond Redemption Fund with which to pay for the cost of additional meters and installation thereof in the system as it presently exists, and

WHEREAS, there is not foreseen sufficient funds in the future with which to pay for said meters, now, therefore,

BE IT RESOLVED that there shall be a meter charge of \$50.00 assessed against each user of water in said district except for those users as located in

Section 1. This \$50.00 assessment shall be spread over the following three billing periods:

Section 2. All Resolutions or parts of Resolutions in conflict herewith are hereby repealed.
