A RESOLUTION OF THE BOARD OF WATER COMMISSIONERS OF WHATCOM COUNTY WATER DISTRICT NO. 8, WHATCOM COUNTY, WASHINGTON, ANNEXING CERTAIN PROPERTY TO WHATCOM COUNTY WATER DISTRICT NO. 8

WHEREAS, on the 127 day of January, 1978, the Board of Commissioners hereinafter called the Board, of Whatcom County Water District No. 8, Whatcom County, Washington, held an annexation hearing concerning the request to annex certain properties into Whatcom County Water District No. 8; and

WHEREAS, this hearing was held pursuant to statute and proper notices were published and posted as required by law; and

WHEREAS, at the time and place stated in said notice and publication, a public hearing was held on said petition; and

WHEREAS, the Commissioners have determined all the area described in the aforesaid request should be annexed to the District; and

WHEREAS, no written or oral objections were raised to the annexation of this property into the District;

NOW, THEREFORE, be it resolved by the Board of Water Commissioners of Whatcom County Water District No. 8, Whatcom County, Washington, as follows:

Section 1: The Board hereby finds that the property hereinafter described in the attached Exhibit "A" should be and is hereby annexed to the District.

Section 2: The said area shall be annexed and become a part of Whatcom County Water District No. 8 effective upon approved by the Board of Commissioners of Whatcom County.

Section 3: A certified copy of this Resolution shall be filed with the Board of County Commissioners, Whatcom County, Washington.

Beginning at the Southeast corner of Section 13, Township 40 North, Range 1 West, W.M.;

Thence Westerly along the South line of said Section 13 and the South line of Section 14, said township and range, to its intersection with the East line of Butler and Moore's Five Acre Tracts, according to plat thereof recorded in Volume 2 of plats, page 45, records of Whatcom County, Washington;

Thence Northerly along said East line to the East West centerline of said Section 14;
