Resolution No. 346

A RESOLUTION of the Board of Commissioners of Whatcom
County Water District No. 8, Whatcom County, Washington,

WHEREAS, during the course of converting the computer programming for Whatcom County Water District No. 8 to the new billing system, Chuck Stirling, an employee of the District, expended a large number of hours as here and after set forth over and above forty hours per week performing said task; and

WHEREAS, there was no agreement between Whatcom County Water District No. 8 and Chuck Stirling concerning the manner in which he would be compensated for spending said extra hours over and above a small amount of compensatory time off; and

WHEREAS, Chuck Stirling spent the following number of hours in the following months over and above forty hours per week and over and above compensatory time off:

April, 1978 - 20 hours
May, 1978 - 23 hours
July, 1978 - 10 hours
August, 1978 - 1 hour
September, 1978 - 23 hours
October, 1978 - 5 hours
November, 1978 - 25 hours
January, 1979 - 44 hours
February, 1979 - 12 hours
March, 1979 - 71 hours
April, 1979 - 40 hours
May, 1979 - 26 hours; and

WHEREAS, the Commissioners of Whatcom County Water District No. 8 believe that they are not required under state or federal law to pay time and one-half to Chuck Stirling for over time hours; and

WHEREAS, Chuck Stirling's hourly wage for April through September, 1978, was \$4.56; and his hourly wage for October, 1978 through March, 1979, was \$5.39; and his hourly rate for April and May of 1979 was \$5.97;

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Commissioners of Whatcom County Water District No. 8 that Chuck Stirling shall be paid extra compensation as follows:

For the seventy-seven hours from April, 1978 through September, 1978, at \$4.56 per hour: Total - \$351.12;

For the one-hundred-fifty-seven hours from October, 1978 through March, 1979, at \$5.39 per hour: Total - \$846.23;

For the sixty-six hours for April and May, 1979, at \$5.97 per hour:
Total - \$394.02;

TOTALS: three hundred hours for \$1,591.37.
