

RESOLUTION NO. 372

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF WHATCOM COUNTY WATER DISTRICT NO. 8, WHATCOM COUNTY, WASHINGTON, AUTHORIZING INSTALLMENT PAYMENTS OF LATECOMER'S CHARGES AND AMENDING RESOLUTION NO. 314.

BE IT RESOLVED by the Board of Commissioners of Whatcom County Water District No. 8, Whatcom County, Washington, as follows:

Section 1: Resolution No. 314 is hereby amended to read as follows:

The manager of the District is authorized to enter into agreements substantially in the form of Exhibit A attached hereto for the payment in installments of latecomer's charges assessed pursuant to Resolutions 75, 139, 149 and 222 or any amendments thereof, provided:

(1) The total charge for water hookup or for sewer hookup must be more than ONE THOUSAND DOLLARS (\$1,000.00);

(2) Before entering any such agreement, the District must receive a down payment of twenty (20%) percent of the amount of the latecomer's charge (or the service connection charge for water, whichever is greater);

(3) The number of equal annual installments in said contract shall in no event exceed nine (9) in number, and, in the case of property being connected subject to a Developer Extension Agreement, the time for payment shall not extend beyond the life of the Developer Extension Agreement;

(4) The first annual installment under said contract shall be due one (1) year after the date of the contract and on the same date each year thereafter, unless the anniversary date shall fall on a Saturday, Sunday, or holiday, in which case the due date shall be the first working day thereafter;

(5) There shall be added to the principal sum due under said contract interest at the rate of Twelve (12%) percent per annum on the unpaid balance until said principal is paid;

(6) Sixty (60) days after non-payment of any annual installment, the entire unpaid principal and interest shall become due, and said sum shall thereupon be considered a delinquent connection charge under Resolution Nos. 75, 139, 149, 222, or any amendments thereof, and the District shall thereupon assess applicable penalties and certify said delinquency to the County Treasurer for lien foreclosure proceedings pursuant to the laws of the State of Washington;

(7) The District shall record said agreement, at the owners expense, giving notice thereof to subsequent purchasers of the subject properties.

Section 2: This resolution shall become effective on the date of its passage and shall apply to any latecomer's charge installment applications made but not completed prior to that date.

Section 3: All resolutions or parts of resolutions that conflict herewith are hereby repealed.

AGREEMENT FOR PAYMENT OF LATECOMER'S CONNECTION CHARGE

THIS AGREEMENT, by and between _____, hereinafter termed the "Owner" and WHATCOM COUNTY WATER DISTRICT NO. 8, hereinafter termed the "District",

W I T N E S S E T H:

WHEREAS, the Owner has connected his private utility system from the hereinafter described property to the District's water/sewer system (cross out one) and is thereby liable for payment of the latecomer's charge pursuant to Resolutions 75, 139, 149, 222 and any amendments thereto, of Whatcom County Water District No. 8; and

WHEREAS, the Owner desires to pay the aforementioned latecomer's charge on an installment basis, pursuant to the terms of Resolution 314 of Whatcom County Water District No. 8, and said Owner has made a down payment in accordance with said resolution;

NOW, THEREFORE, IT IS HEREBY AGREED by and between the parties as follows:

1. In consideration of the District's accepting connection of the Owner's water/sewer (cross out one) to the District's system prior to receipt of full payment of the latecomer's charge owing to the District the Owner promises to pay to the order of the District the principal sum of _____ Dollars (\$_____) and interest at the rate of twelve(12%) percent per annum on the unpaid balance until said principal is paid.

2. Said principal, together with interest as aforesaid, shall be paid by the Owner to the District in _____ equal installments of _____ Dollars (\$_____) commencing on the _____ day of _____, 19____, which calendar date shall be the annual due date for subsequent installments, unless the anniversary date shall fall on a Saturday, Sunday or holiday, in which case the due date shall be the first working day thereafter. The Owner shall have the right of prepayment in any installment year, the Owner agrees to pay that current year's interest.

3. Sixty days after default in any of the aforementioned annual installments by the Owner, the entire unpaid principal and interest shall become due, and said sum shall thereupon be considered a delinquent connection charge under Resolution 75 or 139 of Whatcom County Water District No. 8 or any amendments thereof, and the District shall thereupon assess applicable penalties and certify said delinquency to the county treasurer for lien foreclosure proceedings pursuant to the laws of the State of Washington.

4. The Owner's obligations hereunder shall be binding on the Owner's heirs, successors and assigns and shall be a covenant running with the land, the legal description of which is as follows:

5. The Owner agrees to pay all costs for recording this agreement, all additional computation costs in the event of prepayment, and such attorney's fees and costs as the court may adjudge reasonable in the event of suit to collect the unpaid balance and/or foreclose the aforementioned lien.
