

RESOLUTION NO. 413

RESOLUTION OF THE BOARD OF COMMISSIONERS OF  
BIRCH BAY WATER DISTRICT NO. 8, WHATCOM COUNTY, WASHINGTON,  
RAISING THE CHARGES FOR USE OF ITS SEWER SYSTEM,  
FIXING RATES AND CHARGES FOR SEWAGE DISPOSAL SERVICE  
AND AMENDING RESOLUTIONS NO. 139, 301, 383, and 391

BE IT RESOLVED by the Board of Commissioners of Birch Bay Water District No. 8, Whatcom County, Washington, as follows:

Section 1: Section 1 of Resolution No. 139 and Section 1 of Resolution Nos. 301, 383, and 391 shall be amended to read as follows:

1. The following rates and charges for furnishing sewage disposal services to property within the District, where available, whether or not a connection to the sewage system of the District has been made, within the following classifications of users, are hereby fixed and shall be paid therefor, to-wit:

a. Residential within the District: \$8.50 per living unit per month; plus fifty cents (\$.50) per one hundred (100) cubic feet of water used at said residence. Provided, However, that for any periods covered by the months of July, August, September and October, the fifty cents (\$.50) per one hundred (100) cubic feet charge shall be applied only to the first eight hundred (800) cubic feet of water used at said residence.

b. Residential outside the District: \$12.75 per living unit per month; plus seventy-five cents (\$.75) per one hundred (100) cubic feet of water used at said residence. Provided, However, that for any periods covered by the months of July, August, September and October, the seventy-five cents (\$.75) per one hundred (100) cubic feet charge shall be applied only to the first eight hundred (800) cubic feet of water used at said residence.

c. Commercial (Public Retail, Non-Residential): \$8.50 per month minimum charge per business; plus fifty cents (\$.50) per 100 cubic feet of water used.

d. Industrial (any non-governmental user of publicly owned treatment works identified in the Standard Industrial Classification Manual 1972, Office Management and Budget, as amended and supplemented under the following divisions: Division A: Agriculture, Forestry and Fishing; Division B: Mining; Division D: Manufacturing; Division E: Transportation, Communications, Electric, Gas and Sanitary Services; Division I: Services; A user in the Divisions listed may be excluded if it is determined that it will introduce primarily segregated domestic wastes from sanitary conveniences):

Rates to be established individually by contract to be commensurate with other charges in the District, however, rates will comply with the Federal Guidelines and/or regulations pursuant to the Water Pollution Control Act Amendments of 1972.

Section 2: BE IT FURTHER RESOLVED that any resolution or parts of resolutions in conflict herewith are hereby repealed insofar as they conflict with the sewer service charges herein adopted.

Section 3: This resolution shall be effective January 1, 1985.
