

RESOLUTION NO. 444

A RESOLUTION OF BIRCH BAY WATER  
DISTRICT NO. 8, REGARDING SALE OF  
ULID FORECLOSURE PROPERTY TO GEORGE  
HARRISON.

WHEREAS, BIRCH BAY WATER DISTRICT NO. 8 has previously fore-  
closed it's delinquent ULID Assessment against Tract A, Birch Bay  
Park, First Addition; and

WHEREAS, the Water District Commissioners have previously author-  
ized the sale of a 50 foot square parcel of said property to GEORGE  
HARRISON for \$900.00 plus segregation costs; and

WHEREAS, said purchaser was to receive the property free of any  
ULID assessments; and

WHEREAS, the proceeds of said sale were deposited to the general  
fund, and expenses of sale of \$258.70 were paid from the general fund;  
Now Therefore,

BE IT RESOLVED by the Commissioners of Birch Bay Water District  
as follows:

Section A. The net proceeds of the sale to Harrison, \$641.30, shall  
be transferred from the General Fund to the Sewer Revenue Bond Fund.

Section B. The Whatcom County Treasurer is hereby directed to apply  
\$102.90 of said funds to payment in full of the ULID #2 assessment  
against the following described property:

That portion of Tract "A", Birch Crest Estates, Division No.  
1, according to plat thereof recorded in Volume 9 of Plats,  
Page 95, in the Auditor's office of Whatcom County, Washington,  
described as follows:

Beginning at a point on the Southeast corner of Lot 7, Block 11,  
Birch Bay Park, First Addition, said point being on the West  
line of Sterling Avenue; Thence South along said West line 50  
feet; Thence West parallel with the South line of said Lot 7,  
50 feet to the South line of said Lot 7, Thence East 50 feet to  
the point of beginning.


Situate in Whatcom County, Washington.

The balance shall be applied against the assessment of the aforementioned  
Tract A.

Section C. This resolution shall become effective immediately upon its  
passage.


