In addition, if the engineering cost to the District is more than One Hundred and 00/100ths Dollars (\$100.00), the property owner requesting segregation shall pay such additional costs incurred for engineering services in performing the segregation before receiving the segregation for filing. It shall be the responsibility of the property owner requesting segregation to notify the proper county authorities of the segregation. No segregation shall be issued unless all delinquent assessments are brought current.

Section 2: Resolution No. 376 is hereby repealed.
