Section 2: The Manager of the District is hereby instructed to cause a Notice of said hearing, in the form attached hereto, designated as Exhibit B and incorporated by reference herein, to be published twice in the Bellingham Herald prior to said hearing date and is further instructed to post three (3) copies of said notice in three (3) public places within the area proposed for annexation.
