

RESOLUTION NO. 49

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF WHATCOM COUNTY WATER DISTRICT NO. 8, WHATCOM COUNTY, WASHINGTON, FIXING THE TIME AND PLACE FOR HEARING ON A PETITION FOR ANNEXATION OF CERTAIN TERRITORY TO THE DISTRICT.

WHEREAS, there has been filed with the Board of Commissioenrs of Whatcom County Water District No. 8, of Whatcom County, Washington (hereinafter called the "Board") a petition asking that certain territory be annexed to the District, a copy of which petition is attached hereto designated Exhibit "A", and incorporated by reference herein; and

WHEREAS, the Board has examined said petition and the signatures appended thereto and has caused the signatures to be checked against the respective tracts and parcels of land as appear in the records of the Auditor of Whatcom County, Washington; and

WHEREAS, the Board finds that the above-described petition is signed by the owners of not less than 60% of the area of land within the territory proposed to be annexed, that such territory is contiguous to and in the same county as Whatcom County Water District No. 8;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Whatcom County Water District No. 8 as follows:

SECTION 1: That the petition for annexation of certain territory to Whatcom County Water District No. 8, a copy of which is attached hereto and designated as Exhibit "A", is entertained by the Board and a public hearing on such proposed annexation shall be held on the 18th day of January, 1973, at the hour of 7:30 o'clock, p.m., at the office of the Whatcom County Water District No. 8, at the office of LE COCQ, SIMONARSON, SYRE & JOHNSON at their Blaine office at 838 Peace Portal Drive, Blaine, Washington, at which hearing all interested persons are invited to appear and voice approval or disapproval of said proposed annexation.

SECTION 2: The Superintendent of the District is hereby instructed to cause a Notice of said hearing, in the form attached hereto, designated Exhibit "B" and incorporated by reference herein, to be published once in the Bellingham Herald prior to said hearing date and is further instructed to post three (3) copies of said notice in three (3) public places within the area proposed for annexation.

We further state that the annexation of said territory will be conducive to the public health, welfare and convenience, and will be of special benefit to the land included within the boundaries of said territory.

Beginning at the North 1/4 corner of Section 23, Township 40 N. Range 1 West, W.M.;

Thence Easterly along the North line of said Section 23 to the East 1/16 line;

Thence Southerly along said East 1/16 line to the Northerly right of way line of Birch Point Road No. 482 in the NE 1/4 of said Section 23;

Thence Easterly and Southeasterly along said right of way line to the 1/4 line of said Section 23;

Thence Westerly along said 1/4 line to the Westerly margin of Birch Point Road No. 482 in Govt. Lot 2 in said Section 23;

Thence Southeasterly along the West right of way line to a road running Southwesterly through said Govt. Lot 2;

Thence Southwesterly along the West side of said Road to a creek;

Thence Westerly along said creek to the 1/4 line of said Section 23;

Thence Northerly along said 1/4 line of said Section 23 to the North 1/4 corner and the point of beginning.
