

RESOLUTION NO. 506

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF BIRCH BAY
WATER AND SEWER DISTRICT, WHATCOM COUNTY, WASHINGTON,
FIXING THE TIME AND PLACE FOR HEARING ON A PETITION FOR
ANNEXATION OF CERTAIN TERRITORY TO THE DISTRICT

WHEREAS, the property used by the District for its sewer plant
is currently not within the boundaries of the District; and

WHEREAS, the Board of Commissioners of Birch Bay Water and
Sewer District, of Whatcom County, Washington, (hereinafter called
the "Board") have determined that it should be annexed into the
District; and

WHEREAS, the legal description of said property is attached
hereto and designated Exhibit A, and incorporated by reference
herein; and

WHEREAS, the Board finds that such territory is contiguous to
and in the same county as Birch Bay Water and Sewer District;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners
of Birch Bay Water and Sewer District, as follows:

Section 1: That the petition for annexation of certain
territory to Birch Bay Water and Sewer District, a copy of which is
attached hereto and designated as Exhibit A, is entertained by the
Board and a public hearing on such proposed annexation shall be
held on the 22nd day of October, 1992, at the hour of 4:30
o'clock p.m. at the office of Birch Bay Water and Sewer District,
4895 Birch Bay Lynden Road, Blaine, Washington at which hearing all
interested persons are invited to appear and voice approval or
disapproval of said proposed annexation.

Section 2: BE IT FURTHER RESOLVED that legal notice of the
pendency of said petition and said hearing be given as provided by
law and by statute of the State of Washington.

PETITION FOR ANNEXATION
TO BIRCH BAY WATER AND SEWER DISTRICT

TO: The Commissioners of Birch Bay Water and Sewer
 District, Blaine, Washington

We, the undersigned, being the owners of more than 75% in value according to the assessed valuation for general taxation of the property hereinafter described, and which property is contiguous and adjacent to Birch Bay Water and Sewer District do, by these presents, petition the Commissioners of Birch Bay Water and Sewer District to incorporate said real estate within the district limits of the water district and annex the same thereto as a part of Birch Bay Water and Sewer District.

We understand that Birch Bay Water and Sewer District has placed the following conditions upon the approval of this annexation. They are: n/a

The legal description of the property which we own and which we request Birch Bay Water and Sewer District to annex is as follows:

The North half of the Northwest quarter of the Southwest quarter of Section 1, Township 39 North, Range 1 West of W.M. Situate in Whatcom County, Washington.
