A RESOLUTION OF THE BOARD OF COMMISSIONERS OF BIRCH BAY  
WATER AND SEWER DISTRICT, WHATCOM COUNTY, WASHINGTON,  
REVISING SECTION 2.04.010 OF THE BIRCH  
BAY WATER AND SEWER DISTRICT CODE  
REGARDING BOARD OF COMMISSIONERS MEETINGS

WHEREAS, the Board of Commissioners regularly scheduled meetings are held at 4895 Birch Bay Lynden Road, Blaine, Washington 98230, and;

WHEREAS, the Board of Commissioners desire to change the meeting place to a new address; now, therefore

BE IT RESOLVED by the Board of Commissioners of Birch Bay Water and Sewer District, Whatcom County, Washington as follows:

Section 1: Section 2.04.010 of the Birch Bay Water and Sewer District Code is revised to read as follows:

2.04.010 Meetings -- Date, time and place. Every other Thursday, commencing as of November 19, 1992, at 4:30 p.m., at the premises known as the office of Birch Bay Water and Sewer District, Whatcom County, Washington, located at 7096 Point Whitehorn Road, Birch Bay, Washington 98230-9675, are fixed as the time, date and place for regular meetings of the Board of Commissioners; and such meetings shall be so held until further act of the Board of Commissioners.

Section 2: BE IT FURTHER RESOLVED that any resolutions or parts of resolutions in conflict herewith are hereby repealed insofar as they conflict with the provisions of this resolution.

Section 3: If any section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Resolution. The Council hereby declares that it would have passed this code and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases has been declared invalid or unconstitutional, and if, for any reason, this Resolution should be declared invalid or unconstitutional, then the original Resolution or Resolutions shall be in full force and effect.

Section 4: This Resolution shall be in full force and effect on November 5, 1992.
