

RESOLUTION NO. 510

A RESOLUTION OF THE BOARD OF COMMISSIONERS  
OF BIRCH BAY WATER AND SEWER DISTRICT, WHATCOM  
COUNTY, WASHINGTON, ADDING A NEW SECTION TO  
CHAPTER 8.08 OF THE BIRCH BAY WATER AND SEWER DISTRICT CODE

BE IT RESOLVED by the Board of Commissioners of Birch Bay Water and Sewer District, Whatcom County, Washington as follows:

Section 1: There is added to Chapter 8.08 of the Birch Bay Water and Sewer District Code a new section as follows:

8.08.050 Application for Service. Upon application for service for any premises within the District boundaries, if the owner or former owners have not paid a proportionate share of the construction cost of the sewer line along the premises, there will be a charge in lieu of assessment. The charge in lieu of assessment shall be paid in full before sewer service is supplied to the premises. The charge in lieu of assessment shall be calculated at the rate of \$35.00 per front foot. Where sewer service is sought for one single family residence on a tract larger than one (1) acre in size, a lot of 100 front feet may be segregated for computing the charge in lieu of assessment.

Section 2: BE IT FURTHER RESOLVED that any resolutions or parts of resolutions in conflict herewith are hereby repealed insofar as they conflict with the provisions of this resolution.

Section 3: If any section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Resolution. The Council hereby declares that it would have passed this code and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases has been declared invalid or unconstitutional, and if, for any reason, this Resolution should be declared invalid or unconstitutional, then the original Resolution or Resolutions shall be in full force and effect.

Section 4: This Resolution shall be in full force and effect on December 3, 1992.
