

RESOLUTION NO. 527

A RESOLUTION OF THE BOARD OF COMMISSIONERS  
OF BIRCH BAY WATER AND SEWER DISTRICT,  
WHATCOM COUNTY, WASHINGTON

BE IT RESOLVED by the Board of Commissioners of Birch Bay Water and Sewer District, Whatcom County, Washington as follows:

Section A: Section 8.08.050 of the Birch Bay Water and Sewer District Code is amended as follows:

8.08.050 General Facilities Charges. Any application for sewer service shall be subject to a general facilities charge of ONE THOUSAND FOUR HUNDRED NINETY SEVEN AND NO/100THS DOLLARS (\$1,497.00) per equivalent living unit to be connected to the District's sewer system in addition to any connection, permit or inspection fees otherwise applicable.

Section B: Section 8.08.060 of the Birch Bay Water and Sewer District Code is amended to read as follows:

8.08.060 Connection after General Facilities Charge payment. Any property which has previously paid a general facilities charge for sewer service, but not paid for monthly sewer charges, shall receive a credit against the charge levied in paragraph A hereof as follows:

If the amount paid was less than \$922.00 per RCE, the credit shall be 1.625 times the amount paid.

If the amount paid was \$922.00 per RCE, then the credit shall be as follows:

Section C: BE IT FURTHER RESOLVED that any resolutions or parts of resolutions in conflict herewith are hereby repealed insofar as they conflict with the provisions of this resolution.

Section D: If any section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Resolution. The Council hereby declares that it would have passed this code and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases has been declared invalid or unconstitutional, and if, for any reason, this Resolution should be declared invalid or unconstitutional, then the original Resolution or Resolutions shall be in full force and effect.
