

RESOLUTION NO. 70

A RESOLUTION of the Board of Commissioners
of Whatcom County Water District No. 8,
WHATCOM COUNTY, WASHINGTON,
Annexing certain Property to the District

WHEREAS, on the 7th day of June, 1973, the
Board of Commissioners (hereinafter called the "Board") of Whatcom
County Water District No. 8, Whatcom County, Washington, adopted
Resolution No. 67 entertaining a certain petition for annex-
ation to the District of the property hereinafter described, fixing
the time and place of hearing upon said petition, and providing for
the publication and posting of notice of the hearing; and

WHEREAS, such notice was published and posted as required by law
and by said Resolution No. 67; and

WHEREAS, at the time and place stated in said Resolution No. 67
a public hearing was held upon said petition; and

WHEREAS, the Commissioners have determined that all of the area
described in the aforesaid petition should be annexed to the District;

NOW THEREFORE, BE IT RESOLVED by the Board of Water Commissioners
of Whatcom County Water District No. 8, Whatcom County, Washington as
follows:

SECTION 1: The Board hereby finds that the property hereinafter
described should be, and it is hereby, annexed to the District:

Beginning at the Northeast corner of Section 23, Township 40 North,
Range 1 West, W.M.; thence Southerly along the East line of said Section
23 to its intersection with the East-West centerline of said Section 23;
thence Westerly along said East-West centerline to its intersection with
the Easterly right-of-way line of Birch Bay Road No. 482; thence Northerly
and Westerly along said right-of-way line to its intersection with the
West line of the East half of the Northwest quarter of said Section 23;
thence Northerly along said West line to its intersection with the North
line of said Section 23; thence Easterly along said North line to the Northeast
corner of said Section 23 and the Point of Beginning.

SECTION 2: Said area shall be annexed and become a part of
Whatcom County Water District No. 8, effective on the 1st day of
June, 1973.

SECTION 3: Certified copies of this Resolution shall be filed
with the Board of County Commissioners, Whatcom County, Washington.
