A RESOLUTION OF THE BOARD OF COMMISSIONERS OF BIRCH BAY WATER & SEWER DISTRICT, WHATCOM COUNTY, WASHINGTON, APPROVING ANNEXATION OF THE LOOMIS TRAIL AREA TO THE DISTRICT ("LOOMIS TRAIL" ANNEXATION)

WHEREAS, on June 9, 2011, the Board of Commissioners approved Resolution No. 702, which resolved the District to file a notice of intention application ("NOI") with the Boundary Review Board ("BRB") pursuant to Chapter 36.93 RCW, to annex certain property to the District located in Whatcom County, Washington as described in Exhibit A hereto (the "Property"); and

WHEREAS, said NOI was filed with the BRB, and the 45 day time period for the BRB to assume jurisdiction expired on August 28, 2011; and

WHEREAS, pursuant to Chapter 1.12.040(B) of the District Code, the Board may, in its discretion, approve the annexation by resolution; and

WHEREAS, approval of the annexation for which said NOI was filed with the BRB is in the best interest of the District and the District hereby confirms all recitals in favor thereof set forth in Resolution No. 702; and

WHEREAS, the foregoing recitals are findings of the Board of Commissioners of the Birch Bay Water and Sewer District and are a material part of this resolution;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Birch Bay Water and Sewer District, Whatcom County, Washington as follows:

<u>Section 1</u>: The District hereby resolves to annex the Property described in Exhibit A hereto, to the District.

<u>Section 2</u>: BE IT FURTHER RESOLVED that any resolution or parts of resolutions in conflict herewith are hereby repealed insofar as they conflict with the provisions of this Resolution.

Section 3: If any section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of the Resolution. The Board hereby declares that it would have passed this code and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases may be declared invalid or unconstitutional, and if, for any reason, this Resolution should be declared invalid or unconstitutional, then the original Resolution or Resolutions shall be in full force and effect.

Section 4: This Resolution shall be in full force and effect retroactive to August 29, 2011.
