

RESOLUTION NO. 738

A RESOLUTION OF THE BOARD OF COMMISSIONERS
OF BIRCH BAY WATER & SEWER DISTRICT, WHATCOM COUNTY,
WASHINGTON, AMENDING DISTRICT CODE TO REVISE WATER AND SEWER
SERVICE FEES AND CHARGES

WHEREAS, the Board of Commissioners ("Board") of the Birch Bay Water & Sewer District ("District") is responsible for setting fair and equitable fees and charges consistent with State law for the services and products it provides; and

WHEREAS, some of said fees and charges are intended to be revised; and

WHEREAS, the District has previously consolidated its fees and charges to a single location in the District Code; and

WHEREAS, the foregoing recitals and findings are a material part of this Resolution;


NOW, THEREFORE, be it resolved by the Board of Commissioners of Birch Bay Water and Sewer District, Whatcom County, Washington as follows:

Section 1: Portions of District Code section 7.04.070, 7.04.081, 7.04.110, 8.08.050 shall be amended as set forth in Exhibit A to this Resolution. All other lines, amounts, code sections, references, and descriptions in those sections shall remain unchanged.

Section 2: If any section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this Resolution. The Board of Commissioners hereby declare that it would have passed this code and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases has been declared invalid or unconstitutional, and if, for any reason, this Resolution should be declared invalid or unconstitutional, then the original Resolution or Resolutions shall be in full force and effect.

Section 4: This Resolution shall become effective January 9th, 2015.
